- Owner agrees that the Project shall be constructed and maintained strictly in 3. compliance with the plans and specifications approved by PDCCA as outlined in the approved ARC Request and that the project shall be kept in good maintenance and repair.
- 4. Owner understands that if any Association owned property, i.e. common areas. are disturbed, altered, changed or damaged due to the project, owner will assume full responsibility to return the affected area(s) back to its original condition, the costs of which will be borne solely by owner. If affected area(s) is not repaired

- within a reasonable time, or not repaired to PDCCA's satisfaction, PDCCA has the right to repair the affected areas and charge to owner all applicable costs.
- 5. Approval of any particular plans and specifications or design shall not be construed as a waiver of the right of PDCCA to disapprove such plans and specifications, or any elements or features thereof, in the event such plans are subsequently submitted for use in any other instance by any other homeowner.
- 6. There shall be no deviations from the ARC Request, including the plans, specifications, and location, as approved by PDCCA without prior written consent of PDCCA; any variation from the original ARC Request must be resubmitted for PDCCA approval.
- 7. Owner authorizes members of the ARC Committee, Board and/or staff from the PDCCA office to enter upon owner's property to make one or more routine inspection(s) regarding the Project.
- 8. Owner understands that it is owner's responsibility to pay all costs and expenses incurred in the construction of the project, and to be fully responsible for maintenance, repair and replacement of the project.
- 9. Owner agrees to assume all responsibility for any damages to persons, property or otherwise which may result from the construction, maintenance, use or continued existence of the project and shall hold PDCCA free and harmless from any and all costs and expenses attributable to the construction installation, maintenance, repair, or replacement of the project or to its continued existence or use.
- 10. Owner agrees that all construction, maintenance and continued use of the project shall be in accordance with generally accepted construction, maintenance and repair practices and in compliance with all local, state and federal regulations, ordinances, laws and building codes. PDCCA's approval of the project shall not be construed as an acknowledgement that the project complies with applicable laws. Owner shall be obligated to obtain any necessary building permits and inspections and to verify compliance with all requirements imposed by law.
- 11. The project shall remain subject in all respects to the jurisdiction of PDCCA and to the CC&Rs, Bylaws, Rules and accordance with the approved ARC Request; PDCCA shall have the power, at owner's expense, to remove the project in the PDCCA's sole discretion.
- 12. Owner shall be responsible for securing and maintaining adequate insurance for the project. PDCCA shall have no obligation to insure the same.
- 13. Owner releases PDCCA, its Board of Directors, officers, members, agents and employees from any duty or obligation to pay, or otherwise to be responsible, for the cost of construction, maintenance, repair or replacement of the project and further releases and indemnifies said parties from any and all claims, injuries, damages and causes of action which may arise as a result of the construction, maintenance, repair or replacement of the project or the continued existence or use of the project.
- 14. Owner understands that project must be completed within 180 days of work commencement; one additional extension of 180 days may be granted by PDCCA, upon written request to PDCCA.
- 15. OWNER UNDERSTANDS THAT NO WORK ON THE PROJECT SHALL COMMENCE UNTIL PDCCA'S WRITTEN APPROVAL OF THE ARC REQUESTS RECEIVED, IF WORK HAS BEGUN WITHOUT PDCCA'S PRIOR WRITTEN

APPROVAL, OWNER UNDERSTANDS THAT THIS ACTION IS A VIOLATION AND OWNER MAY BE ASKED TO REMOVE IT.
